1. CALENDAR DESCRIPTION

This course is an introduction to the study of the development of the individual throughout the life cycle. Emphasis will be placed on the interrelationships between physiological, sociological and psychological aspects of normal human development.

2. COURSE DESCRIPTION

This course focuses on human development which is often referred to as developmental psychology. It is about how human beings change over the course of their life, involving developmental stages (i.e., pre-natal and postnatal development, infancy, early childhood, middle childhood, adolescence, emerging adulthood, established adulthood, and adulthood) and special issues (e.g., aging, grieving, death and dying). Attention is given to how thinking, feeling, social interactions, and behaviors change throughout the lifespan.
